From Your President

The SVAA has received a letter from the City Manager responding to concerns over hangar lease issues including insurance requirements for hangar tenants. In response to an earlier letter delivered to all hangar tenants, the SVAA met with the City Manager and provided a considerable amount of information regarding lease provisions at other airports and information regarding traditional hangar use activities and insurance availability for various types of general aviation aircraft.

As stated at our meeting with the City Manager, the SVAA agrees that reasonable insurance protection should be provided by hangar tenants. Unfortunately, the January 12 letter does not appear to adequately clarify ambiguities in the earlier letter which have caused concern for many pilots.

The SVAA Board will request a meeting in the near future with all appropriate City staff to discuss this matter and hopefully obtain clarification of the recent letter. All SVAA members are encouraged to submit concerns and comments through the SVAA so that our positions can be presented in an organized and consistent manner.
